Regular Agenda Items:

1. Final Contract Payment - C.P. 01-241-0

I would like authorization by the enclosed resolution to make the final contract payment to J.R. Ferche, Inc. in the amount of \$16,201.20 for this project, which was a grading, aggregate base, and bituminous surfacing project on an 0.6 mile segment of County Road 241 on the Itasca County line. The final contract amount of \$316,021.12 is approximately 5% above the bid amount of \$300,097.78. The cost overrun was because of larger quantities of aggregate base and bituminous pavement that were necessary to complete the project.

2. Engineering Service Agreement - CSAH 4 bridge

In April 2011, I had discussions with the Board about the need to post a number of our timber bridges to restrict the loads on these bridges. One of those bridges was on CSAH 4 over the Rice River, which is 53 year old structure.

I have recently solicited engineering service agreements from Erickson Engineering of Bloomington, MN and Widseth, Smith, Nolting (WSN) of Alexandria, MN for design of a replacement structure for this bridge. The Erickson Engineering quote amount was \$25,500 and the WSN quote amount was \$23,600. I therefore would like authorization to enter into the agreement with WSN for this design work.

3. Local Road Improvement Program - Resolution for Grant Application

Last year, the state legislature made \$10 million available statewide for the Local Road Improvement Program. MnDOT is now soliciting project candidates for this program, with a submittal deadline of February 3, 2012. Part of the grant application includes a county board resolution. At our annual meetings this week, I anticipate getting further guidance about the program, so I have not yet decided which project I will submit. I need to schedule this agenda item at this time, as it is the last scheduled meeting before the grant application deadline. I will have a recommended project and accompanying resolution by the Board meeting date on January 24th.

WHEREAS, Contract No. 20103— Project Nos. C.P. 01-241-01 — Grading and Aggregate Base, Bituminous Surfacing has in all been completed, and the County Board being fully advised in the premises,

NOW THEN BE IT RESOLVED, That we do hereby accept said completed projects for and in behalf of the County of Aitkin and authorize final payment to J. R. Ferche, Inc. in the amount of \$16,201.20 as specified herein.
