Sand Bag Policy Discussion

The County Board asked staff to look into creating a policy for the use of sand bags in the event of flooding in Aitkin County. Staff has contacted several counties and the Minnesota Counties Insurance Trust (MCIT). With each contact to the different counties we were given the same answer. MCIT does not recommend creating a policy to provide sand, sand bags, staff, or a location for these activities for liability purposes; therefore their county does not have a policy. Several of the counties did create policies for distributing sand bags to local governments (townships and cities) to protect public infrastructure.

I spoke with a couple of representatives from MCIT and they gave me the same response. MCIT feels that the County would be adding undue liability by bringing individuals onto county property to fill sand bags for individual properties. They indicated that giving out sand bags to local governments to protect public infrastructure is an alternative.

At this time a formal policy might not be necessary, in keeping with action of surrounding counties.
