I. Approval of Agenda

II. Approval of Minutes of the December 7, 2011 Meeting

Emergency Preparedness Presentation Stacey Durgin, PH Educator, gave a PowerPoint Presentation on the Public Health Emergency Preparedness (See attached printout) and the Aitkin County Mass Dispensing Plan of medications and the Management Reform Act addressing natural disasters, acts of terrorism, and other man-made disasters.
- **IV.** Responses to Questions from AEOA:
 - A. With respect to Meals on Wheels (Marilyn Ocepek) No response yet from Ms. Ocepek. Tricia Martin updated the committee that Meals on Wheels serves 55 residents in and around the city of Aitkin and approximately 20-30 meals per month to rural delivery. There are about 28 recipients that each get 10-15 meals per person per delivery.

B. With respect to the Blue Bus Schedule – (Pam Smith)

1. How is the word getting out to residents about the availability of the bus in various areas of Aitkin County?

Because of "flat funding" (we're not getting an increase in our funds), advertising on radio and newspapers is no longer an option for us. We depend a lot on "word of mouth" and organizations like yours to help us get the word out.

2. Are there any plans for outreach to communities in Aitkin County, i.e. McGrath, and McGregor?

There is nothing planned at this time, this goes back to the answer above, flat funding prevents mass media advertising. I am available and have spoken to groups in Aitkin County promoting Arrowhead Transit and am very willing to go again or to other groups that would like to have me!

Pam also attached a pdf copy of the Aitkin County and Aitkin City schedules for you. Tricia Martin noted she had a received a bunch of the schedules and would bring them for the committee members next month.

V. Hot Topics for Discussion

- A. Dave Leaf brought up the need for sub-committees to be formed to discuss specific issues with the involvement of this committee in order to possibly do more in the community/county. Looking for ideas from HHS or the Commissioners with things this committee could look into at the community level. Tom noted there will probably be some transition things that will be coming up and how they could be communicated to the public. A couple suggestions for sub-committees that could be developed include one on Transportation in Aitkin to get the word out about the various types of transportation assistance available. The second suggestion was the Food Shelves and how to get the information out to folks that the food shelves are available in various areas of the county and opportunities for folks to volunteer at the food shelves as well as overcoming the cultural barriers.
- B. Dave Leaf also questions the need to have Community Recognition on the agenda every month and the need for clarification of who the recipients could/should be or whether or not the guidelines need to be revamped or clarified. Discussed the fact that we want to recognize the "service provided" and not necessarily the employees of the company/organization. Copies of the current Community Recognition Guidelines will be sent to committee members for review and revisions if necessary.
