- A. **Caseload Update & Graph** Eileen Foss, Income Maintenance Supervisor, updated the Board that because of the CAP Agency reductions, we are seeing an increase in requests for assistance resulting in an increased number of cases.
- B. **Financial & Transportation Reports** Kathy Ryan, Fiscal Supervisor, reviewed the Financial Reports with the Board.
- C. Child Protective Services (FGDM & Triple P) Sue Tange reviewed the Memo included in the packet. Sue noted that for the three years (2009-2010-2011) for 12 cases using either the FGDM or Triple P, the cost of the supportive services was \$8,776.31.

- A. **H&HS Advisory Committee** Commissioners Westerlund and/or Marcotte Meeting updates from Committee Members: Cheryl Meld & Tricia Martin See attached minutes from the December 7th, 2011 meeting. Commissioner Westerlund discussed the presentation made by Sue Tange at the Dec. 7th meeting on Foster Care and Levels of Care and Costs.
- B. Tri-County Community Health Services Board Commissioner Westerlund noted they had Dale Gordon, CPA, at the meeting for an audit, noting various items to be addressed. They had a Triad update, and also discussed flu clinics noting the various responses to folks getting flu shots this year (some clinics have lots of serum left and others are nearly out). Noted that the doctor that was their consultant retired and a new physician in Itasca County has agreed to the position.
- C. AEOA / NEMOJT Committee Updates Commissioner Napstad noted AEOA has not met this quarter but meets tomorrow. NEMOJT met this month noting the grants the agency receive. Much of the discussion centered around the MFIP contracts and reductions.
- D. CJI (Children's Justice Initiative) Commissioner Westerlund didn't attend the CJI meeting.
