The Aitkin County Board of Commissioners met this 6th day of March, 2012 at 9:02 a.m. with the following members present: Chairperson J. Mark Wedel, Commissioners Laurie Westerlund, Don Niemi, Brian Napstad, Anne Marcotte, County Administrator Patrick Wussow, and Administrative Assistant Sue Bingham.

Motion by Commissioner Westerlund, seconded by Commissioner Marcotte and carried, all members voting yes to approve the March 6, 2012 agenda.

Motion by Commissioner Napstad, seconded by Commissioner Niemi and carried, all members voting yes to approve the Consent Agenda as follows: A) Correspondence File: February 28, 2012 – March 5, 2012; B) Approve Minutes: February 28, 2012; C) Approve Resolution – Exempt Permit LG220 of the Long Lake Conservation Foundation; D) Approve Resolution – Support for Legislation Modifying Wetland Replacement Requirements

Under the consent agenda, motion for a resolution by Commissioner Napstad, seconded by Commissioner Niemi and carried, all members voting yes to approve resolution – Support for Legislation Modifying Wetland Replacement Requirements:

WHEREAS, State Representative Anzels has authored legislation modifying wetland replacement requirements in counties with 80% or more of their pre-settlement wetland remaining, officially known as House File No. 2105, and

WHEREAS, Aitkin County has in excess of 80% of their pre-settlement wetlands remaining, and

WHEREAS, current state law regulating replacement of wetlands affected by building activities creates undue hardship for economic development activities in Aitkin County, and

WHEREAS, modification of wetland replacement requirements in Aitkin County would enhance local economic development, and

WHEREAS, the provisions of HF 2105 are in full compliance with statutory requirements that Minnesota retain an overall no net loss of wetlands policy.

2105, modifying wetland replacement requirements, as proposed by State Representative Anzelc.

Beth Leaf, Executive Director CARE discussed the services provided by CARE, and reviewed the 2011 Year End Report with the Board.

Carroll and Joy Janzen, Aitkin Area Persian Gulf Support Group presented new drawings to the Board for the proposed Veterans Memorial in front of the Courthouse, and set Sunday, July 1, 2012 for the dedication.

Motion by Commissioner Napstad, seconded by Commissioner Westerlund and carried, all members voting to set the dates of April 10, 2012 at 10:00 a.m. and April 24, 2012 at 11:00 a.m. for Public Hearings for Redistricting of Aitkin County Commissioner Districts. Both Public Hearings will be held in the Boardroom of the Aitkin County Courthouse.

Mark Jacobs, Land Commissioner conducted a Public Hearing for Land Classification of Tax-Forfeited Lands. There were no public comments other than two letters of support. Motion for a resolution by Commissioner Marcotte, seconded by Commissioner Napstad and carried, all members voting yes to approve resolution - Classification of Lands Forfeited to the State for Taxes:

WHEREAS, under Statute 282, the Aitkin County Board of Commissioners, is acting on behalf of the state under laws allowing the county board to classify and manage tax-forfeited lands held by the state in trust for the local units, and

WHEREAS, parcels of land becoming the property of the state in trust under law declaring the forfeiture of lands to the state for taxes must be classified by the county board of the county in which the parcels lie as conservation or nonconservation. In making the classification the board has considered the present use of adjacent lands, the productivity of the soil, the character of forest or other growth, accessibility of lands to established roads, schools, and other public services, their peculiar suitability or desirability for particular uses, and the suitability of the forest resources on the land for multiple use and sustained yield management. The classification, furthermore, must: (1) encourage and foster a mode of land utilization that will facilitate the economical and adequate provision of transportation, roads, water supply, drainage, sanitation, education, and recreation; (2) facilitate reduction of governmental expenditures; (3) conserve and develop the natural resources; and (4) foster and develop agriculture and other industries in the districts and places best suited to them, and

WHEREAS, a public meeting was held on March 6th, 2012 at the regular county board meeting and that prior to meeting for the purpose of classifying or reclassifying tax-forfeited lands, the county board gave notice of its intent to meet for that purpose in postings, on the web site, and in the local newspaper, in addition to sending letters to any township or city in which the properties were located, and

WHEREAS, at the meeting, no objections were raised on any of the attached parcels.


