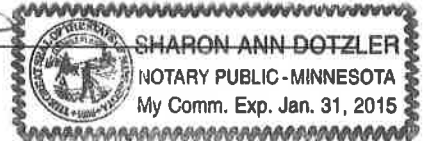

Present at the meeting were Chairperson J. Mark Wedel, Commissioners Laurie Westerlund, Don Niemi, and Brian Napstad. Commissioner Marcotte was absent. County Administrator Patrick Wussow, and Administrative Assistant Sue Bingham were also present.

Motion carried, Napstad/Westerlund (4-0 Marcotte absent), to approve the September 11, 2012 agenda.

Motion carried, Napstad/Niemi (4-0 Marcotte absent), to approve the consent agenda;

To approve September 4, 2012 County Board minutes;

To approve Final Plat of Rabbit Lake Cemetery;

To adopt Resolution - Fund Transfer - Road & Bridge

Motion carried, Napstad/Niemi (4-0 Marcotte absent), to uphold the potentially dangerous dog designation - Kaiser
