Grant Monies Available for Cleaning or Sealing Flooded Wells In Aitkin, Carlton, Pine and South St. Louis Counties

The 2012 Special Session of the Minnesota Legislature appropriated funds to the Minnesota Department of Health (MDH) to provide assistance to well owners whose wells were contaminated by the flooding during June and July 2012 in Aitkin, Carlton, Pine, and southern St. Louis counties. The funds are directed at wells that experienced persistent bacterial contamination having two or more tests showing the presence of coliform bacteria, and not clearing up after one or more attempts at well disinfection. Funds can also be used for sealing wells that will not be returned to use because of flood damage.

Well owners may be eligible for reimbursement of up to \$1200 for well cleaning and or well sealing performed by a licensed well contractor. The reimbursement will be available through the local Soil and Water Conservation District. To be eligible for reimbursement, the well must have had two positive tests for the presence of coliform bacteria since June 19, 2012. All expenses for well cleaning and/or well sealing must be documented in an invoice provided by the well contractor. If the well has been sealed, the well owner must also submit a copy of the Well and Boring Sealing Record.
