On June 21st, 2012 we shut down The Corner Club due to damage sustained during the catastrophic flooding in Aitkin County. At that time, the second half of our liquor license fee was due. We did not pay it because at that time, we did not know if we would be back in business before the end of the year. We were told at that time, by Kirk Peyser, that if/when we were able to reopen that our license would be reinstated and we would just have to pay a prorated amount for the remainder of the license period. On October 12th, we went to Terry Neff, asking if there was any way we could possibly save the old bar due to its nostalgic value and that our best time of the year (deer hunting) was almost upon us! Because the water never entered the main level of the building and we could repair the basement for less than apx. \$53,000, Terry gave us the go ahead to fix and reopen The Corner Club. We only had 19 days to complete the repairs and get everything in order to accomplish our goal of being open for deer season. We paid the 2nd half of our property tax and went to the Auditor's Office to pay the prorated amount for our liquor license. We were then told that we had to reapply for our license just like we were starting from day one. I questioned this, but Sally Huhta insisted and told me that we would have to fill out the entire application again and that we would have to get all the signatures required. The County Attorney's secretary questioned why we were the ones bringing the application to them instead of the Auditor's Office. We told her that they were too busy with election business to do this portion. When I brought the information in to Sally by the (wrong) date she had told me, I was

told it was late and that it would have to be pushed to the next meeting. I wanted to pay our prorated amount but was told they had not yet figured it out. This meant that we would not be approved before opening hunting. We decided to just not charge for liquor. Our food license was still in force, our insurance was current and we opened on November 2nd. The prorated amount was paid on the 5th. The next meeting was to be on November 6th. All our information was already at the Auditor's Office, yet we were still not put on the docket for this meeting. We continued to not charge for liquor.

On Saturday the 10th, County Administrator Patrick Wussow and County Investigator Steve Sandberg came to The Corner Club due to an anonymous complaint that we were illegally selling alcohol. We explained that we have not been charging for liquor and that whatever money the customer's left on the bar was purely, completely up to them. He also explained the difficulties we had encountered trying to get our license reinstated. They did not shut us down but asked that we attend this board meeting to resolve the issue.

We do not believe it should have been necessary for us to reapply for a brand new license. We had already been approved through 2012, and as stated before, Kirk Peyser told us it would be automatically reinstated with a prorated fee. We closed down because of a natural disaster, not due to any violation or involuntary suspension of our license. We were not notified of any cancellation.

FEMA, the State of Minnesota and Aitkin County Social Services did absolutely nothing to help us when we had lost both our business and home. The Auditor's Office giving us conflicting information and incorrect dates has made it very difficult for us to get back to normal business. Our not charging for liquor has substantially affected our bottom line during our busiest time of the year.

Our fees are paid and the license already in our possession is valid thru Dec 31, 2012. We request that our liquor license be reinstated as it should have automatically been in the first place! We ask that they consider this new application as our early renewal for 2013. Only a couple of dates would need to be changed.

Dear Commissioner Wedel:

I am pleased to inform you that your county has satisfied the requirements for distribution of the First Half of FY13 SCORE block grants. Electronic payment representing the First Half of your county's total FY13 SCORE disbursement will be processed to the county treasurer.

In order to receive disbursement of future SCORE grant funds, your county must continue to satisfy all of the following requirements:

- establish a separate general fund account for the grant,
- match the grant with at least 25 percent local funds,
- spend the grant funds and matching funds only on eligible programs,
- submittal of an annual report on county expenditures and resulting improvements in waste management, and
- have in place an approved county solid waste management plan and required updates.

If at any time the county does not meet all of these requirements, the block grant funds must, by law, be withheld.

The Minnesota Pollution Control Agency looks forward to assisting your county in the implementation and operation of SCORE programs. We anticipate distribution of the second half of the FY13 SCORE Block Grant in April 2013.
