Final Contract Payment - Contract No. 20062

Summary:

Authorization by the enclosed resolution is requested to make final payment to Central Specialties, Inc. in the amount of \$300,000 for construction of various projects under contract No. 20062 in 2006. These projects included bituminous pavement work on CSAH 3, CSAH 7, Hill City Trail, Crow Wing CSAH 1, at the Palisade and McGregor Maintenance Facilities, and bituminous patches on various roads. The final contract amount of \$2,970,193.22 is approximately 8% above the bid amount of \$2,743,579.05. The increased cost was due to increased quantities of material used on various projects, a number of required change orders on the projects, and finally, a mediated settlement agreement that had gained previous County Board approval.
