Authorization by the enclosed resolution is requested to make final payment to Anderson Brothers in the amount of \$5,295.69 for construction of three projects under contract No. 20122 in 2012. These projects included bituminous pavement work at the McGregor Airport, CSAH 14, and CSAH 36, all in the McGregor area. The final contract amount of \$1,059,138.50 is approximately 0.6% above the bid amount of \$1,052,727.66. The McGregor Airport Commission has authorized final payment for the airport project.
