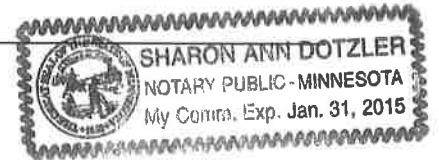

The meeting was called to order at 6:11 p.m. in Courtroom One of the Aitkin County Courthouse

Also present were County Administrator Patrick Wussow, County Auditor Kirk Peysar, Environmental Services Director Terry Neff, Sheriff Scott Turner, County Treasurer Lori Grams, IT Director Steve Bennett, County Attorney Jim Ratz, Economic Development Coordinator Ross Wagner, County Recorder Diane Lafferty, County Engineer John Welle, and Administrative Assistant Sue Bingham.

The budget process was discussed, the 2014 proposed budget and levy was presented, and the Board heard public comment.
