

**Synopsis of the Aitkin Board of Commissioners meeting of July 25, 2017**  
**In pursuance of MN Statute 375.12, Subd. 1.**  
The meeting was called to order at 9:03 a.m.  
Present at the meeting were Board Chair J. Mark Wedel, Commissioners Laurie Westerlund, Don Niemi, Bill Pratt, Anne Marcotte, County Administrator Jessica Seibert, and Administrative Assistant Sue Bingham.  
Motion carried, Westerlund/Pratt, to approve July 25, 2017 agenda.  
Motion carried, Westerlund/Niemi, to approve the consent agenda  
To approve July 11, 2017 County Board Minutes  
To adopt Resolution: Federal Recreational Trail Program Grant  
To adopt Resolution: LLCC IRRRB Grant Application  
Motion carried, Marcotte/Niemi (4-1 Wedel), to approve \$100,000 grant to SCI Broadband for Bridge Road area on Big Sandy Lake, and to delay consideration of a \$50,000 grant to Mille Lacs Energy Cooperative / Consolidated Telecommunications Co. until the August 8th County Board meeting. The approval of the grant to SCI Broadband is contingent upon approval of contract by the County Attorney.
