#### Public Hearing – Small Cities Development Program

The purpose of this Public Hearing is Aitkin County's application to the Small Cities Development Program.

Aitkin County is in the process of submitting a full application to the SCDP for Housing Rehabilitation funds in Wagner and Williams Townships. The program will give loans for qualified households in the form of forgivable loans for program eligible expenses.

Nicole Klosner of Lakes and Pines will be present for more details on the application and program guidelines.

Projects must meet one of three federal objectives:

- Benefit people of low and moderate incomes
- Eliminate slum and blight conditions
- Eliminate an urgent threat to public health or safety

In addition, Cities with fewer than 50,000 residents and counties with fewer than 200,000 residents are eligible. Need, impact and cost effectiveness must be documented and the general public must be involved in the application process.

A proposed Resolution is attached, if approved it will be placed on the standard Aitkin County Resolution.
