This results in a 3.5% increase which is equivalent to the staff pattern settlement of one-half percent general adjustment, plus a step increase, not to exceed the scale maximum. The personnel committee met on November 13, 2018, and unanimously recommends:  3.5% = an increase of \$1,058.86/year.  2018 Salary \$30,253.00. 2019 Salary \$31,311.86.
