Summary of Issue:
Attached are two requests to extend the recycling agreements with Garrison Disposal and Countryside Sanitation. We have had agreements with both companies for many years. Garrison Disposal operates our recycling center in Aitkin and the remote drop off locations in the County. Countryside Sanitation operates the McGregor Transfer Station. I recommend we extend the recycling agreements with each of the companies for an additional year which will expire on December 31, 2021.

Both agreements allow for renegotiation during the term of the agreement, if necessary, due to unknown circumstances.
