- January 2005 April 2006
 - Primary responsibilities included teaching independent living skills, social skills, anger management, and coping skills to the serious and persistent mentally ill population. Case load of 28 people with mental illness/dual diagnosis, facilitated goal oriented groups to the dual diagnosis population titled MI/CD. Ran the day treatment program which included a support group, independent living skills group, and recreation group.
