I'm requesting approval from the Aitkin County Board of County Commissioners to accept a bid from Oberg fence, of Deerwood, to remove the damaged fence and replace with a new chain link privacy fence on the south and west side of the race track. The fence was damaged beyond repair in May of 2022 as a result of straight line winds. This fence replacement will be funded by insurance reimbursement and FEMA.
