**Aitkin County Cannabis Ordinance**

**WHEREAS**, Minnesota Statute 342 has authorized Aitkin County regarding local registration and enforcement of state-licensed cannabis retail businesses, and to adopt reasonable restrictions of the time, place, and manner of the operation of a cannabis business provided that such restrictions do not prohibit the establishment or operation of cannabis businesses; and

**WHEREAS**, The Aitkin County Board of Commissioners deems it necessary to adopt a Cannabis Ordinance that addresses the legal cannabis market while prioritizing the protection of public health, safety, and community well-being through the regulation of the sale and use of cannabis and cannabinoid derived products within Aitkin County. This ordinance aims to ensure the regulations governing cannabis mitigate potential health risks, prevent youth access, support public safety, and encourage responsible retailing practices; and

**WHEREAS**, Aitkin County has provided proper public notice of this proposed cannabis ordinance and has held a public hearing for said ordinance on October 22, 2024 which was open for public comment; and

**NOW, THEREFORE BE IT RESOLVED**, that the Aitkin County Board of Commissioners hereby adopts and approves the newly established Aitkin County Cannabis Ordinance effective January 1, 2025.


